5. Space will be assigned on a first-come, first serve basis.
6. If you will need any audio/visual, it must be so noted on the Product Demonstration Reply form and after the Conference, you will be billed. Please note: You must bring your own computer. Computers will not be provided.
7. All Product Demonstration meeting room space will be set "Classroom" style to accommodate a maximum of 30 people.
